The basic area of coverage of this course is current issues of European labour law and social policy. That, in practice will also cover a wide area of EU substantive law, through which the socio-economic life of the Union is regulated. Relevant EU Treaties will be analyzed, as well as the European Union Charter of Fundamental Rights. After a short introduction of the international and regional European labour law framework, students will be acquainted with major EU social policy case-law and secondary legislation in the fields of free movement of workers and European social citizenship, employment rights and work organisation, non-discrimination and gender equality law, work-life balance of employees, transfer of undertakings and collective redundancies, working time and non-standard forms of employment, social rights and economic freedoms, posting of workers, social dialogue and collective bargaining, employee information, consultation and participation.

By the end of this course, students should be able to comprehend some of the major issues of the European social integration process and to distinguish the specific features of the European social model in an international and comparative law context.
